In other words, employers need to switch to internet banking for October, 2016 contribution which is payable by 15th November, 2016 and onwards;


2.2 Employers submitting self-printed 8A Form are requested to switch to SOCSO's pre-printed 8A Form (or internet banking) for ease of processing of the same by 30th June, 2016. In other words, employers need to switch to SOCSO's pre-printed 8A Form or internet banking for July, 2016 contribution which is payable by 15th August, 2016 and onwards.
